



2017 Mutual Aid District Training Incentive Fund



The Mutual Aid District Training Incentive Fund was implemented by the Office of the Fire Commissioner in an effort to promote and enhance training at the Mutual Aid District level across the Province. This highly successful initiative has proven, over the years, to provide quality courses at the district level that would otherwise be difficult for many municipal departments to obtain.

The \$11,500.00 is allocated annually per Mutual Aid or Training District to train and/or upgrade the qualifications of the active members of their participating departments. Courses eligible for Training Incentive Funds are the Manitoba Emergency Services College courses only and must be taught by an MESCC Emergency Services Instructor for that specific program area. Monies are paid directly to the Mutual Aid or Training District based on the successful completion of the course in accordance with the following fee schedule:

ADDITIONAL FUNDING SUPPORT

Fire Departments or Mutual Aid Districts hosting the MESC's Vehicle Extrication Seminar will be eligible to claim \$150.00 per vehicle up to a maximum of \$1,500.00 per Seminar.

Fire Departments or Mutual Aid Districts hosting the MESC's School Bus Rescue or Farm Accident Rescue Seminar will be eligible to claim a maximum of \$1,500.00 per Seminar for the purchase of school bus(s) or farm machinery.

Fire Departments or Mutual Aid Districts submitting Training Incentive Invoices for vehicle(s), school bus(s) or farm machinery must ensure they are sent to the MESC complete with the appropriate supporting documentation (Page 3 of the Mutual Aid District Training Incentive Invoice), including the original Vendor's invoice indicating proof of payment.

The funds generated by the District through this initiative are used to support the continued development and enhancement of District's training capacity through the initiatives such as the development of the District's Instructor network.

All Mutual Aid Incentive Invoices MUST be submitted to The Office of the Fire Commissioner, 1601 Van Horne Avenue East, Brandon Manitoba R7A 7K2 by December 31st of each year.
