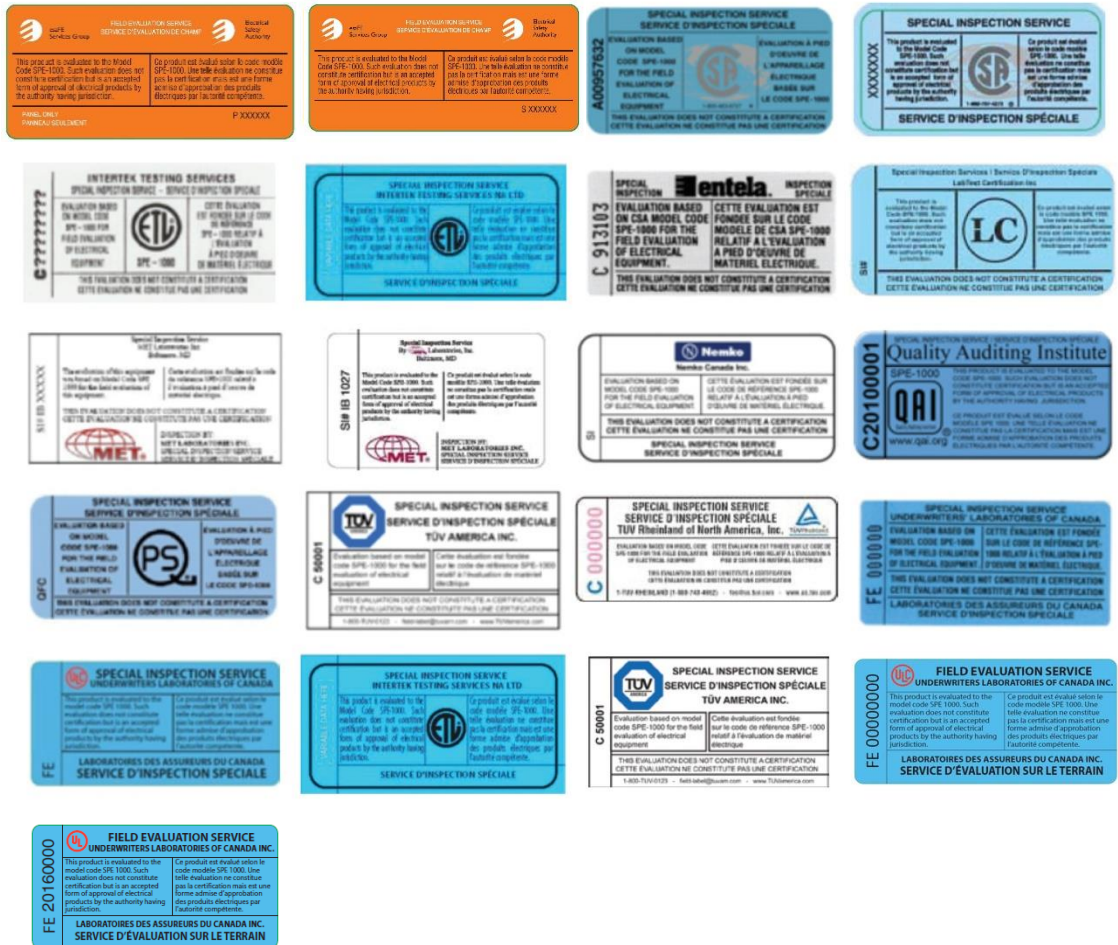

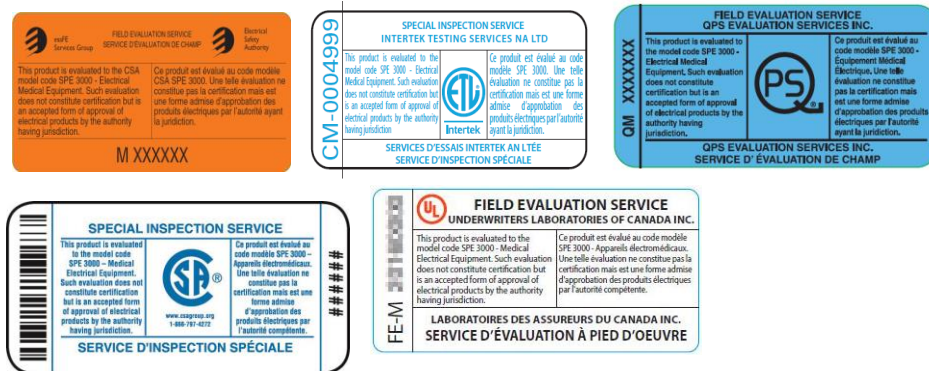

Recognized Labels for field approval of medical equipment:



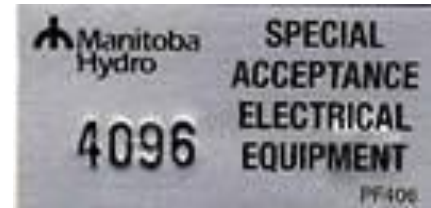
